With regard to declaring Agra as a heritage city, it is submitted by learned Additional Solicitor General that a request has been made to the State of Uttar Pradesh for giving a proposal.

Learned counsel for the State of Uttar Pradesh states that a Study has already been awarded to Centre for Environment Planning and Technology, State of Gujarat and they have framed certain terms of reference. She says that the Study will take some time.

With regard to Management Plan to be submitted to UNESCO, it is submitted by learned Additional Solicitor General that

the first draft is ready and it is expected to be finalized within eight weeks after which it will be submitted to UNESCO.
